

CLOSING AND SALE OF ROAD

IN THE MATTER OF THE MUNICIPAL ACT 2001, S.O. 2001, CHAPTER 25, SECTION 34 AND AMENDMENTS THERETO

TAKE NOTICE that the Council of the Corporation of the Township of East Hawkesbury proposes to pass a By-Law to close, stop and sell the road(s) listed below;

ROAD CLOSING AND SALE: All and singular that certain parcel or tract of land and premises situate, lying and being in the Township of East Hawkesbury, in the County of Prescott and being composed of all that portion of the original road(s) allowance described as follows:

FIRSTLY

All that portion of the Road Allowance between Lots 6 and 7, Concession 5, in the Township of East Hawkesbury, in the County of Prescott, more particularly described as follows:

COMMENCING at the southwesterly corner of Lot 6, Concession 5, in the said Township of East Hawkesbury;

THENCE northerly, along the easterly limit of the said Road Allowance, a distance of 3,340 feet more or less to a point in the easterly limit thereof distant 100 feet South from the southwesterly corner of that portion of Lot 6, Concession 5, in the said Township of East Hawkesbury, designated as Part 2 on Plan 46R-5094;

THENCE westerly, perpendicularly with the said easterly limit of the Road Allowance, a distance of 40 feet to the westerly limit of the said Road Allowance between Lots 6 and 7;
THENCE southerly, along the said westerly limit of the Road Allowance, to the southeasterly corner of Lot 7, Concession 5, of the said Township of East Hawkesbury;

THENCE easterly, along the northerly limit of the Road Allowance between Concessions 5 and 6 in the said Township of East Hawkesbury, to the Point of Commencement.

SECONDLY

All that portion of the Road Allowance between Lots 6 and 7, Concession 6, in the Township of East Hawkesbury, in the County of Prescott, more particularly described as follows:

COMMENCING at the northwesterly corner of Lot 6, Concession 6, in the said Township of East Hawkesbury;

THENCE southerly, along the easterly limit of the said Road Allowance, to a point in the easterly limit thereof at the intersection with the northerly limit of the bed of the La Graise River at its most southerly crossing of the said Road Allowance;

THENCE westerly, along the said northerly limit of the bed of the La Graise River, to the westerly limit of the said Road Allowance between Lots 6 and 7;

THENCE northerly, along the said westerly limit of the Road Allowance, to the northeasterly corner of Lot 7, Concession 6, of the said Township of East Hawkesbury;

THENCE easterly, along the southerly limit of the Road Allowance between Concessions 5 and 6 in the said Township of East Hawkesbury, to the Point of Commencement.

SAVE AND EXCEPT the bed of the La Graise River where the said river crosses again the said road allowance between Lots 6 and 7, just South of the said Road Allowance between Concessions 5 and 6.

THIRDLY

All that portion of the Road Allowance between Concessions 5 and 6, in the Township of East Hawkesbury, in the County of Prescott, more particularly described as follows:

COMMENCING at the southwesterly corner of Lot 6, Concession 5, in the said Township of East Hawkesbury;

THENCE easterly, along the northerly limit of the said Road Allowance, to a point in the northerly limit thereof at the line between the East half and the West half of Lot 4, Concession 5, in the said Township of East Hawkesbury;

THENCE southerly, perpendicularly with the said northerly limit of the Road Allowance, a distance of 60 feet to the southerly limit of the said Road Allowance;

THENCE westerly, along the said southerly limit of the Road Allowance, to a point in the southerly limit thereof at the intersection with the easterly limit of the bed of the La Graise River where it crosses the said Road Allowance;

THENCE northerly, along the said easterly limit of the bed of La Graise River, to the northerly limit of the said Road Allowance between Concessions 5 and 6;

THENCE easterly, along the said northerly limit of the Road Allowance, to the southeasterly corner of Lot 7, Concession 5, of the said Township of East Hawkesbury;

The proposed By-Law and plan describing that/those part(s) of the road allowance to be closed and sold are available for inspection in the office of the Clerk, Township Hall, 5151 County Road # 14, St. Eugène, Ontario, during normal office hours.

The Council of the Corporation of the Township of East Hawkesbury will consider the aforesaid By-Law at its meeting on December 14, 2009 at the hour of 8:00 p.m. and will hear in person or by his counsel, Solicitor or agent, any person who applies to be heard and:

- (a) who claims that his land will be prejudicially affected by the By-Law; and
- (b) who wishes to object to the actions proposed in the By-Law.

Any person desiring to be heard is asked to contact the undersigned in writing on or before December 14, 2009.
